## From the President

\*HE Australian National Championships are over for this year and Queensland will not be required to host another one until the vear after Brisbane hosts the Olympic Games. Even though the ANC is one-tenth the size of the most recent and final Gold Coast Congress it is still a big effort dependent on many generous workers and volunteers. The number of entries across the two weeks was higher than expected and over 6000 hands were pre-dealt to accommodate. Tournament Organiser Julie Jeffries celebrated her 80th birthday and is to be congratulated on a job very well done. This included editing four ANC Bulletins. Kim and Ray Ellaway were a tower of strength as always, working behind the scenes ensuring

that nothing was overlooked, from financials to equipment to entry management. Directors were Laurie Kelso and Jan Peach with Peter Busch the chief scorer. George Collings acted tirelessly as floor manager and caddy throughout and Sue Smith was a welcome presence at the Help Desk.

There were however plusses and minuses. In the former category was the Brisbane Technology Centre in terms of event management with movable walls for different layouts, comfortable chairs, good lighting, plenty of space, the coffee cart and great co-operation from BTC management. Negative issues including the inconvenient location, the shambolic parking app system and the lack of nearby food outlets on the weekends.

On the bridge front, the highlight for Queensland was the performance of our Youth team (Lauren Morgan, Paddy Taylor, Remco Spencer, Ada Sun, Jasmine Skeate, Alex Wu) captained by Michael Gearing which led throughout the qualifying rounds and was the only Qld team making it into the Finals against Victoria shown on BBO. The 192-124 loss was

disappointing for them but does not detract from their accomplishment.

## When Do You Hang Them Up?

HAVE been playing bridge for over fifty years, most of it with my wife, Anne. By the time this article appears, I will be 72 years old. Bridge has been my passion, my addiction and my escape. It has also been an outlet for my competitive personality.

My microprocessor isn't as fast as it used to be. I just had a coaching session with a couple of juniors. We practiced bidding, and as soon as they saw all four hands they would announce how many tricks the deal made. Not important, but it reminded me that my brain has slowed down.

We played a regional for six days recently. The first four days I played ok, up to my standard. The fifth day I was not up to average, and made some stupid errors. The sixth day I was totally hopeless. I had no endurance, and had run out of gas. Totally fried.

Annie did not play the Memphis NABC's, and I played with an old friend. We did not play the whole tournament and took some days off. For the Summer NABC's in Philly, Annie has said she only wants to play four days, and if I want to play more, it

This is disappointing as it means I will not be playing in the premier event. The truth is we are not as competitive as we once were.

Everyone likes to win. But I hate to lose at bridge more than I enjoy winning. Contrast that with my history of distance running. For most of my life I was a serious runner (I logged over 3000 miles one year) and I would run the local 5k, 10k, and half marathons unless I was tapering for a marathon (of which I would run several a year). I gave dozens of t-shirts to charity. I never once won a race, yet I loved running and racing. Then again, I never had the expectation of winning. I could measure my performance against myself, my prior results and my expectations based on my training. There really isn't an easy way to determine how well you played bridge, other than looking at where you finished.

My mother died of Alzheimers, her sister died of Alzheimers, their mother died of Alzheimers. My brother and I live daily with the fear it will afflict us. While it has been said that playing bridge can slow the onset of dementia including Alzheimers, the evidence is largely unreliable. Science doesn't really know. There may be some genetic relationship, and there are some not statistically-valid test results that suggest using your brain to solve puzzles and games may help, but there is nothing definitive.

Admittedly there are players 15 years my senior — Bob Hamman comes to mind — who are still winning national championships. We don't all age the same. And winning isn't the only objective. I still get enjoyment from solving "bridge puzzles", even if it is lying in bed at 3am replaying the same hand over and over, a task worthy of Sisyphus.

So, when do you hang them up? I could say, "I will quit when you pry the cards from my cold, dead hands." But among other things that would be unfair to my partners and teammates. I never want to hear, "Gee, Dave has really lost it."

There was a fellow here in Colorado, Dick Reed, who won a national championship, quit cold turkey, and never touched another card. That's going out on top. I guess I could have done that five years ago, but I wasn't ready.

While I think it is a legitimate question,

my answer is never going to be final. If you see an old broken down guy wandering around a playing site looking like he is lost, please make sure to say hi.



Jimmy Wallis and Kevin Steffensen had a fabulous carry over and played well in the championship round and won.

We then had three sessions of teams in which our team came fourth. Therese Tully, Paul Hooykaas, Pele Rankin and a Queenslander ring-in, Stephen Fischer from Canberra, won the event. Then it was the premier event, the Swiss Pairs – 4 sessions, 12 matches with play-off points for those chasing them.

We had an exceptional first day,

winning or drawing all our matches and then on the second day, only 2 losses but it was 2 matches where the cards went against us hence so did the scores. We eventually came 7th in this event playing 5 of the pairs above us and we either drew or beat those pairs.

Sitting South I opened 1. Precision and Ray responded 1NT. East doubled showing a one-suiter hand (the system had a name but it went over my head). I bid 3. which sets the suit and asks for cues. After Ray bid 4. I bid 4. Ray bid 4. and I bid 4. 6. was easy to bid as I knew Ray had the K and the A and some outside stuff.

We picked up a lot for this board and upon investigation found 12 of the 20 tables were in 3♦ diamonds. The eventual winners were Lori Smith and Arjuna DE Livera and we were only 2.8 VPs away from third.

The convenor Eileen Bocock retired after 20 years of service and her being in charge was the reason we have attended for the past 20 years so perhaps my last. However, I will still promote the event if there is a chance of it ever being held again. There is still discussions about the 2026 event in Darwin but nothing is set in concrete as yet.


### **ANC Senior Teams**

West led the queen of spades, taken by South in hand with his king. The original declarer proceeded quickly, perhaps after subliminally observing that only a 4-0 club break would create a problem. Declarer decided that because West held longer spades than East that if either defender began with four clubs the odds favoured it being East. As a result, declarer crossed to the ace of clubs and could not believe his luck when East discarded a diamond. There was no way to recover and declarer could do no better than finish with eight tricks.

North was not sympathetic when South complained about his bad luck. "The lay of the club suit allows you to pick up a 4-0 break on either side, provided you guess right. What was the rush to tackle the club suit? It cost nothing to nothing to cash the ace and queen of diamonds before tackling clubs. If both defenders follow twice in diamonds, cash the ace of clubs next. However, when the 6-1 break comes to light, the odds swing to West being the favourite to have four clubs, as West

has more cards in hearts and clubs than East. Consequently, you would then cash the king of clubs first. When East shows out on the first club, you continue with the ten. When West covers the ten with the jack you would win the trick with dummy's queen then cross back to hand with the ace of hearts to lead another club, making six tricks in the suit and two overtricks – a much better result than down one."

What are the odds that West holds four clubs when he has one diamond and five or six spades? In the case where West has six spades, it's about three to one that West rather than East could have four clubs, so the best play at trick four is the king of clubs. A further point in favour of playing the king of clubs when West is short in diamonds is that he would surely have bid differently if he began with twelve cards in the majors.





After East opened with a weak two-bid in third seat, South began with a takeout double. North's 3D suggested around 8-11 points. (With 0-7 points, North would have responded with a Lebensohl 2NT instead.) South's 3S was then forcing, and North suggested a slam by cue-bidding in hearts.

West led his singleton against the spade slam, and declarer took the trick with dummy's ace. Declarer drew trumps in three rounds and played the ace and jack of diamonds, overtaking with dummy's king. When East discarded on the

second round of diamonds, declarer had a diamond loser. A declarer who is put off by this development might discard two hearts on the third and fourth round of diamonds and then fall back on the club finesse.

This declarer saw that if the finesse lost he would finish one down. Relying on a finesse was far from his best option, which was to play the fifth diamond, even though it was not a winner. Declarer discarded the three of clubs from his hand, and West won the trick. As every one of his major suit cards had been removed, West's last four cards were all clubs. So, the forced club return was into declarer's ace-queen, to bring the slam home.




This deal came up in a team game and both sides reached the heart slam on similar auctions, against the opening lead of the queen of clubs.

The first declarer won the opening lead with the ace of clubs and, as he was a straightforward "eight ever, nine never" sort of player, he continued with the ace and king of trumps. When West showed out on this trick, declarer eventually had to rely on the diamond finesse. This failed too, and the slam was down one.

At the other table, after winning the first trick with the ace of clubs, declarer realised that he could improve his chances of making by playing to eliminate the black suits. So, declarer cashed the king of clubs and ruffed dummy's last club,

eliminating that suit. Next, he took the king and ace of spades then ruffed his remaining spade in dummy, eliminating that suit too. After this preparation, declarer played the ace and another trump, and when East followed low he knew it was safe to insert the jack of trumps. If the finesse lost to an original doubleton queen with West, that player would find that he was endplayed. West would then have to play a diamond into declarer's king-jack tenace, or concede a ruff-and-discard. In the latter case, declarer would ruff in dummy and throw a diamond from hand. As the cards lay, the trump finesse succeeded and twelve tricks were guartanteed.

Of note is that the risk of an overruff in hearts or clubs is lower than the chance of losing a trump trick by playing on the suit immediately.

This is another deal from a team game where both South players blasted into 4H on the given auction. The lead was the same at both tables: the jack of clubs. When dummy came down, each declarer saw that the contract had no hope if trumps were 4-0. However, ten tricks would be easy if trumps were 2-2 or when trumps were 3-1, so long as spades were 3-3.

At both tables the jack of clubs won the first trick and both defenders continued with the ten of clubs. After the second round of clubs was ruffed, both declarers turned their minds to coping with trumps 3-1 and spades 4-2. This is the point at which the declarers' plans diverged.

At the first table, declarer cashed the ace of trumps and was relieved to see the suit was not 4-0. Next, he switched his attention to spades. Declarer took the precaution of cashing the ace of spades then played a low spade to dummy's queen, before continuing with a low spade towards his hand. This would succeed in protecting the king of spades against a ruff when East began with a doubleton spade, as then East could only ruff a loser. However, East followed with the nine of spades, so declarer had to play his king, which West ruffed with the jack of trumps. West continued with the king of trumps, leaving declarer with a spade loser for down one.

This declarer could be considered somewhat unlucky – his plan would have succeeded if trumps were 2-2 or spades were 3-3, or when East began with three trumps and least two spades.

At the other table, declarer came up with a better plan to make ten tricks. Instead of cashing the ace of trumps at trick three, he played on spades in the standard way – taking the ace-queen and leading a low spade towards his hand. This time when West ruffed the king of spades declarer was still in control of trumps. After ruffing West's club exit, declarer cashed the ace of trumps before ruffing his remaining spade in dummy. West could make the king of trumps, but that was all.

How do the two lines compare? The first line loses when spades are 2-4 and West began with three trumps. The second line fails when West began with a doubleton spade and a singleton trump, a much less likely occurrence. Of note is that both declarer's played low at trick one because they believed it would be harder for West lead a trump at trick two (in fact a shift to the seven of trumps then would see the defence prevail).

Bridge is essentially a social game, but unfortunately it attracts a large number of antisocial people.



## Directors' Corner

### Telling, not asking

In club land, I am seeing a growing trend of players wanting to know about an opponents call, but they don't ask at their turn, as is their right. Instead, they say something like "so that's XXXX". Often it is a newer player trying to learn rather

than needing to know the meaning of the call before they take some action. They probably mean well but it is poor form in so many ways.

Law 20 is of relevance here, and for a few other club player niggles that have been brought to my attention.

The comment could be something like "so that's Stayman". Maybe the player had poor handwriting, and all the questioner was doing was trying to clarify what call had been made. Law 20A says "A player may require clarification forthwith if he is in doubt what call has been made". Correct procedure is to seek clarification.

Law 20B gives a player the right to have all previous calls restated when it is his turn to call (unless he is required by law to pass). This is moot with written bidding, bidding boxes and online bridge because the player can see all the preceding calls anyway. I'm not sure how I would cope if we still used spoken bidding!!!!

Law 20C.1 says, "After the final pass either defender has the right to ask if it is his opening lead (see Laws 47E and 41)". Thus, it should not be possible for someone to lead when it is not their turn – but even then, there is a mechanism to recover if the incorrect opening lead is made face down as stipulated in Law 41A. Players can be lazy sometimes. If a player asks them "is that Stayman", they might just agree without thinking. Ask them what their partners 2C means and they should give a clear answer eq "Shows 12-

14 and asks me to show a 5-card major or a 6-card minor". Again, encourage your players to ask, not to tell. It is best that they ask about the opponent's auction but Law 20F.3 does allow them to **ask about a single call**, but it cautions that Law 16B.1 (unauthorised information) may apply.

Interestingly, Law 16B.1 also tells us that questions, replies to questions, unexpected alerts and failure to alert constitute extraneous (unauthorised) information. A player still has the right to ask, but they must be aware that it might place pressure on their partner who "may not choose a call or play that is demonstrably suggested over another by unauthorized information if the other call or play is a logical alternative." Getting Directors and

players to understand this is a challenge, and is why many bridge rulings are part remedy and part education.

We have discussed the role of alerting (see QBA Regulations) in earlier articles, some players mistakenly think they are only allowed to ask about alerted calls. They can ask about any call or auction sequence.

Now back to the initial problem. What if an auction goes 1NT 10-13: (P): 2D:????. Then the question comes "Is that a transfer". North - opener says "no, it is a natural suit with 5+D". Questioner quickly passes. Wherever the auction ends up, East now knows that West has diamonds – information

they are not entitled to. A brief explanation of the partnership system before play starts might help, but to be honest, most players don't listen! Next best thing is for East to have read the system card. Next best thing is for East to ask, "please explain". There still might be UI but not as explicit.
